

HARTING FARM POOL RULES 2015

HOURS

- The pool will open on Saturday May 23rd. The 2015 season ends on Labor Day, September 7th.
Pool hours are:
 - Monday – Friday 12 noon – 9 p.m.
 - Saturday, Sundays & Holidays 11 a.m. –9p.m.

- Harting Farm sponsors a swim team. There will be several instances where the main pool and wading pool will open late/close early to community and outside pool members due to swim team obligations. The dates are as follows:
 - Monday June 15th- the pool will close between 1 and 4:30 (rain date 6/16)
 - Saturday June 20th- the pool will only be open to the community **between 1 and 5pm**
 - Saturday July 11th the pool will open at 1pm
 - Saturday July 18th the pool will open at 1pm

- Swim Team will hold practices May 26th to June 19th from 4 to 7pm and will reserve 3 lanes. Practices will switch to mornings, 8am to 1pm, beginning June 22nd and will end July 24th.

MEMBERS

1. A pool member is defined as a person residing in a paid household of the Harting Farm community or immediate family members living in the same household and appearing on pool membership contract.
2. Owners of rental units may elect to keep membership or pass to rental family.
3. Outside pool members are those who have an approved HF pool membership application and risk agreement on file with the HF HOA. Only those listed on the approved applications are considered pool members. You will be considered a community member during the months of pool operations.

ADMISSION

1. Admission to the pool is by verification of information on your pool pass. Pool passes will be maintained by the member and will be required to be shown at entry. Each member of your household will be listed on the pass. Each family will be entitled to two guests daily.
2. All members and guests are required to sign in to the pool each visit.
3. ***Children under the age of 10 years old must be accompanied by a parent or guardian (defined as responsible for member's child in absence of a member adult and must be at least 13 years old)***

GUEST POLICY

1. All guests must be accompanied by a Harting Farm pool member for admission to the pool.
2. Each family will be allowed 2 free guests per day.
3. Additional guests will be permitted by paying a fee of \$2 per person (including children over the age of 1).
If your total number of guests during normal operation times exceeds 15, **you must**
 - Contact the HF pool coordinator at hartingfarmpool@gmail.com to gain approval for 'party status at pool'
 - You may be required to pay an additional guard fee of \$25.00 per hour per guard
4. Guest fees must be paid at the time of visit – there will be a lock box at the entrance of the pool in which to place the fees. Lifeguards will not have change, please bring the exact amount. Checks should be made payable to Harting Farm HOA.
5. The lifeguards will monitor the admission process.

HEALTH REQUIREMENTS

1. Persons with contagious illnesses, skin conditions, bandages, or inflamed eye(s) are not permitted in the swimming pools. Persons with medical conditions that could jeopardize their safety are required to notify the lifeguards prior to entering the water.

2. Smoking, gum/tobacco chewing, expectorating or spitting is not permitted in the pool area. No alcohol permitted during pool hours.
3. Bathing suits must be worn in the pools. Shorts or jeans are not permitted.
4. Children who are not toilet trained must wear tight fitting plastic/rubber pants and disposable swim diaper under their bathing suit. Cloth diapers are not permitted.

RESPONSIBILITIES

1. All persons included on the membership and their guests agree to abide by the regulations listed and any additional rules posted and administered by the Manager/Staff. They further agree to accept the penalties for infraction of those rules and regulations.
2. The lifeguards may remove from the pool area any person who fails to follow the pool rules or practice safe conduct.
3. Members are responsible for all personal property and trash brought onto pool grounds.
4. Parents agree to allow the Manager/Staff to assign and enforce appropriate punishment for their child's rule infraction.
5. Members and their guests agree to be responsible for the cost of all medical expenses incurred for injuries sustained while using the facilities of the Harting Farm Pool and members assume the sole responsibility of any first aid treatment sought and received from the Harting Farm Pool including, but not limited to, allergic reaction to first aid remedies rendered. We request that you bring your medicine or allergic reaction kits with you to the Harting Farm Pool for bee stings, etc.

SAFETY REQUIREMENTS

1. Other than authorized personnel, no one is allowed in the pool area unless a lifeguard is on duty.
2. No glass or breakable containers are permitted within pool area.
3. No alcohol is permitted within pool area.
4. Only coast guard approved floatation aids will be allowed. Water wings are not an approved swim aid and will only be allowed at life guard's discretion if parent is by child's side for swim instruction purposes only.
5. Entry into pool is permitted at lifeguard discretion. Running, pushing, wrestling and boisterous behavior are prohibited.
6. Water games, small tubes & floats, balls, etc. permitted at lifeguard's discretion.
7. Swimmers must exit the water during episodes of thunder or lightening and remain clear of the pools until lifeguards reopen the pools.
8. No diving is permitted.
9. Children unaccompanied by a parent or guardian may be, at lifeguards discretion, required to demonstrate swimming proficiency prior to entering the main pool or deep end alone.
10. A parent or guardian must accompany children using swim aids.
11. No socializing with lifeguards while on guard chair. Lifeguards need to focus on monitoring the pool.
12. An adult (age 18 or older) only swim period is scheduled 15 minutes each hour except for the last hour of pool operation. All children under the age of 18 must completely exit the pool.

BABY POOL

1. All children must be accompanied by and supervised by an adult member 16 years of age or older who is to be present at all times.
2. Children over 8 years old are not permitted to use the baby pool.
